# **ANTI-RAGGING** AND SEXUAL HARASSMENT

# Andhra Pradesh Prohibition of Ragging Act, 1997

Act No. 26 of 1997

AP217

Received the assent of the Governor on the 19th August, 1997, published in the Andhra Pradesh Gazette, Part IV-B (Extraordinary), dated 21-8-1997.

An Act to prohibit Ragging in Educational Institutions in the State of Andhra Pradesh. Be it enacted by the Legislative Assembly of the State of Andhra Pradesh in the Fortyeighth Year of the Republic of India, as follows:

1. Short title, extent and commencement: - (1) This Act may be called the Andhra

Pradesh Prohibition of Ragging Act, 1997.

(2) It extends to the whole of the State of Andhra Pradesh.

(3) It shall be deemed to have come into force with effect from 4th July, 1997.

2. Definitions: - In this Act, unless the context otherwise requires, -

- (a) 'act' includes words either spoken or written or signs or sounds or gestures or visible representations;
- (b) 'Educational institution' means and includes a college, or other institution by whatever name called, carrying on the activity of imparting education therein (either exclusively or among other activities); and includes an orphanage or boarding home or hostel or a tutorial institution or any other premises attached thereto;
- (c) 'Government' means the State Government of Andhra Pradesh;
- (d) 'notification' means the notification published in the Andhra Pradesh Gazette and the word 'notified' shall be construed accordingly;
- (e) 'ragging' means doing an act which causes or is likely to cause insult or annoyance of fear or apprehension or threat or intimidation or outrage of modesty or injury to a student;
- (f) 'student' means a person who is admitted to an educational institution and whose name is lawfully borne on the attendance register thereof;
- (g) All words and expressions used but not defined in this Act shall have the meanings assigned to them under the Andhra Pradesh Education Act, 1982 (Andhra Pradesh Act 1 of 1982) or the Indian Penal Code, 1860 (Central Act 45 of 1860) respectively.
- Prohibition of Ragging: Ragging within or outside any educational institution is prohibited.
- 4. Penalty for Ragging: Whoever, with the intention of causing ragging or with the knowledge that he is likely by such act to cause ragging, commits or abets ragging and thereby,-
  - (i) teases or embarrasses or humiliates a student shall be punished with imprisonment for a term which may extend to six months or with fine which may extend to one thousand rupees or with both; or

- (ii) assaults or uses criminal force to or criminally intimidates a student shall be punished with imprisonment for a term which may extend to one year or with fine which may extend to two thousand rupees or with both; or
- (iii) wrongfully restrains or wrongfully confines or causes hurt to a student shall be punished with imprisonment for a term which may extend to two years or with fine which may extend to five thousand rupees or with both; or
- (iv) causes grievous hurt to or kidnaps or abducts or rapes or commits unnatural offence with a student shall be punished with imprisonment for a term which may extend to five years and with fine which may extend to ten thousand rupees; or
- (v) causes death or abets suicide shall be punished with imprisonment for life or with imprisonment for a term which may extend to ten years and with a fine which may extend to fifty thousand rupees.
- 5. Dismissal of student: (1) A student convicted of an offence under Section 4 and punished with imprisonment for a term shall be dismissed from the educational institution.

(2) A student convicted of an offence under Section 4 and punished with imprisonment for a term of more than six months shall not be admitted in any other educational institution.

- 6. Suspension of student: (1) Without prejudice to the foregoing provisions, whenever any student complains of ragging to the head or manager of an educational institution, such head or manager shall inquire into or cause an inquiry to be made into the same forthwith and if the complaint is prima facie found true, shall suspend the student or students complained against for such period as may be deemed necessary.
- (2) The decision of the head or manager of the educational institution under sub-section (1) shall be final.
- 7. Abetment: (1) If the head or the manager of an educational institution fails or neglects to take action in the manner specified in sub-section (1) of Section 6, such person shall be deemed to have abetted the offence and shall be punished with the punishment provided for the offence.
- (2) If a student commits suicide due to or in consequence of ragging, the person who commits such ragging shall be deemed to have abetted such suicide.
- 8. Other laws not affected: The provisions of this Act shall be in addition to and not derogatory of any law for the time being in force.
- Power to make rules: (1) The Government may, by notification, make rules for carrying out all or any of the purposes of this Act.
- (2) Every rule made under this Act shall immediately after it is made, be laid before the Legislative Assembly of the State, if it is in session and if it is not in session, in the session immediately following for a total period of fourteen days which maybe comprised in one session or in two successive sessions, and if, before the expiration of the session in which it is so laid or the session immediately following the Legislative Assembly agrees in making any modification in the rule or in the annulment of the rule, the rule shall, from the date on which the modification or annulment is notified, have effect only in such modification or annulment shall be without prejudice to the validity of anything previously done under that
- Repeal of Ordinance 12 of 1997: The Andhra Pradesh Prohibition of Ragging Ordinance, 1997 is hereby repealed.



# Anti-Ragging and Sexual Harassment

- To prevent any physical and mental torture or disorder towards any student causing apprehension, dread humiliation or agitation in him or her.
- To create awareness about ragging and ensure a student-friend environment at all times.
- To eliminate ragging in all its forms from the educational institutions in the country.
- They keep vigil and stop the incidents of ragging in the college premises and submit recommendations.



## Students' Grievance cell

## Introduction

The Student's Grievance Cell desires to promote and maintain a conducive and unprejudiced educational environment. The objectives of Students Grievance Cell include the following:

- To support, those students who have been deprived of the services offered by the College, for which he/she is entitled.
- To make officials of the College responsive, accountable and courteous in dealing with the students.
- To ensure effective solution to the student's grievances with an impartial and fair approach.

The Cell enables a student to express feelings by initiating and pursuing the grievance procedure in accordance with the rules and regulations of the College. 'Student's Grievance Cell' enquires and analyses the nature and pattern of the grievances in a strictly confidential manner. Emphasis on procedural fairness has been given with a view to "the right to be heard and right to be treated without bias".

During the year no such major grievances were received. Grievances otherwise received were forwarded to the viceprincipals for immediate redressal. In all such cases prompt action were taken and the matter sorted out. In all cases the aggrieved student was informed of the measures taken and checks in the system were introduced to ensure there was no repetition of the same.

## Objectives of Students' Grievance Cell

- To support, those students who have been deprived of the services offered by the college, for which he / she is entitled.
- To make officials of the college responsive, accountable and courteous in dealing with the students.
- To ensure effective solution to the students' grievances with an impartial and fair approach.

## Functions

- Redressal of Students' Grievances to solve their academic and administrative problems.
- To co-ordinate between students and Departments / Sections to redress the grievances.
- To guide ways and means to the students to redress their problems.

## Students' Grievance Procedure

The grievance procedure is a machinery to sort out the issues between student and college. It is a means by which a student who believe that, he / she has been treated unfairly with respect to his / her academic / administrative affairs or is convinced to be discriminated is redressed. It is a device to settle a problem. It enables to express feelings by initiating and pursuing the grievance procedure in accordance with the rules and regulations of the college. It involves a process of investigation in which 'Student's Grievance Cell' enquires and analyses the nature and pattern of

the grievances in a strictly confidential manner. Matters are disclosed to only those, who have a legitimate role in resolving the matter. Emphasis on procedural fairness has been given with a view to "the right to be heard and right to be treated without bias".

The students are ought to lodge their grievances in the prescribed form available with their Vice-Principal (s) / Dean (s) of the respective department. The form, duly filled, is required to be submitted in the drop box placed outside the Principal's office. The secretary in turn intimates the matter to the committee for necessary action. Final report based on grievance received and resolved will be submitted to the Principal and further course of action will be decided and the same shall be intimated to the students.

## Exclusions

SGC shall not entertain following issues.

 Decisions of the Academic Council / Board of studies and other academic / administrative committees constituted by the college.

Decisions with regard to award of scholarships / fee concessions / awards / medals.

3. Decisions made by college under the Discipline Rules and Misconduct.

4. Decisions of the college in admissions of my courses.

5. Decisions of the competent authority on assessment and examination result.

## Grievance Redressal Cell (GRC)

S.G.A.Government Degree College, Yellamanchili has started Grievance Redressal Cell in 2018 under runs effectively since then. The grievance redressal cell aims to look into the complaints lodged by any student and redress it as per requirement. The students can state their grievance regarding any academic and non — academic matter within the campus through online or offline and grievance/suggestion box.
